In 2023 UCAA started the implementation of the new strategic plan 2023/2027 which focused on six thematic areas of: Promotion of rights to sustainable Livelihoods, Child Protection, Education and Life-skills development, Human Rights, Sexual Reproductive Health Rights (SRHR) and Ending Violence Against Women and Girls (EVAWG), Youth Empowerment, Employment and skilling, Humanitarian Aid and Development and Institutional development Programme. These were developed with contribution of the UCAA staff, BODs, and its stakeholders to guide the implementation of the programs.

Project 1: Children at Risk in Karamoja (CaR) Program

CaR Program overview

UCAA in partnership with Dwelling places and Institute for International Co-operation and Development (C&D), formed a consortium and joined efforts to implement the Children at Risk program in Napak district Karamoja region, and Kampala Capital city.

Project objective: To protect adolescents, street connected children and other vulnerable children, affected by crisis within community from unsafe outmigration from Napak District & KCCA by 2024.

Napak district is located in Karamoja region and has the highest number of children being trafficked with over 80% ending up on the streets of Kampala and other town centers. Child Trafficking and unsafe migration is common in the impoverished area as each year, 400-900 children (90% girls) are migrating from Napak district mainly to Kampala, Soroti, Mbale, Jinja and Nairobi in Kenya.



The push factors include but are not limited to insecurity, harsh climatic conditions that have caused drought, poverty and food insecurity in the region. There is also evidence that children are sometimes lured out of Napak District by their peers, or by individuals (traffickers) promising better opportunities, hence justification for project implementation.

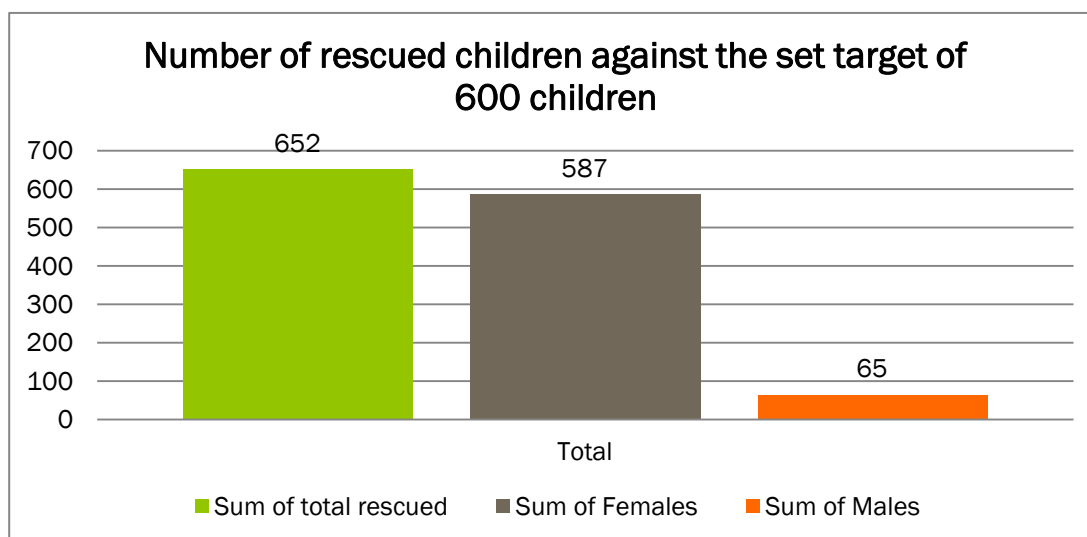
A brief methodology on how the activities are/were implemented

Children were rescued, resettled, rehabilitated and reunited with their family members successfully with support of social workers, family tracing, medical screening, psychosocial support provided and resettlement, spiritual nourishment, first aid, and education services through creative play / educational games using the mobile school. Their data was recorded (Name of the child, the caregiver details, village, parish and the sub county for each child rescued), to help staff during the family tracing and resettlement process and during the continuous follow-ups.

The data is used by the Local leaders and CaR partners for continued support and planning for the children as described: UCAA supports in Sustainable resettlement, Economic Empowerment, Food security through awareness campaigns, backyard gardening, Agribusiness development, Gender based Violence (GBV) and Attitude / Mindset change in the communities. C&D supports in Interception, Reconciles, resettles, Child Protection, Education (Formal & informal), Life skills, Water & sanitation plus psychosocial support to the children and their families, and DP supports in Rescue, rehabilitate: Intercept & reconcile, Education, Health and nutrition.

Summary of project activities that contributed to the anticipated project results

Outcome 1: Adolescents, street-connected and other vulnerable children protected from unsafe outmigration from Napak District.



The project activity had a set target to rescue 600 children, however 652 were got, with 587 Females and 65 Males

The table below shows results of some of the children that were followed up.

Following the subsequent filed visits, the team identified and realized the need for case management support in some households, for example the need for food items and hygienic items like Soap, clothes, even blankets in families where it was only older and weaker grandparents taking care of children.

Also energetic people in some homes always left elderly adults and children in the homes, while they went to do some agriculture jobs during the planting seasons, this left/leaves a high chance of children leaving home, either in search of food or any other motives since the elderly could barely control them. .

Note: This therefore calls for double interventions in form of follow up and case management.

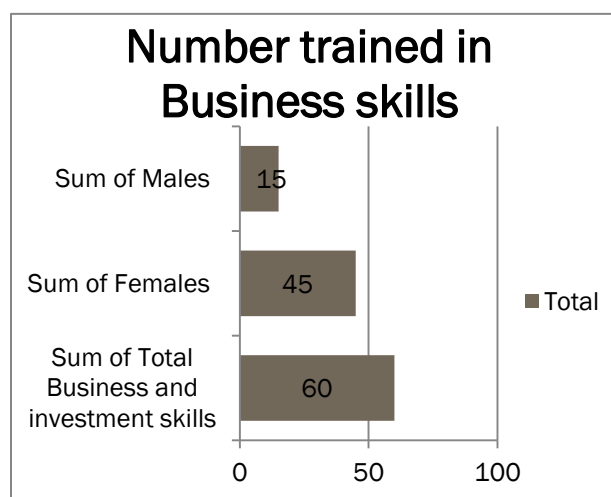
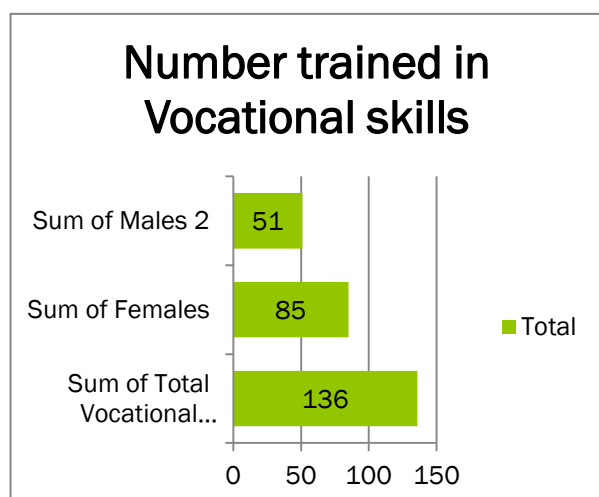

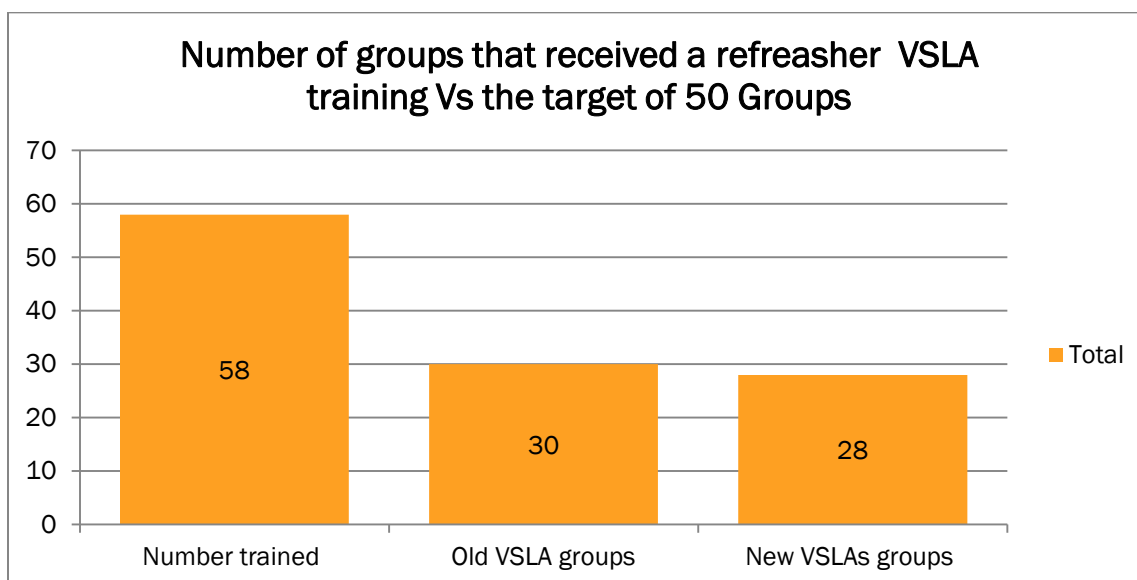
Backyard gardening was established to improve on the nutrition status of the children taken to school, this acted as an opportunity for them to learn and practice the same in their homes and communities.

Outcome 2: Improved Livelihoods of families of rescued and other vulnerable children affected by crisis in Napak District

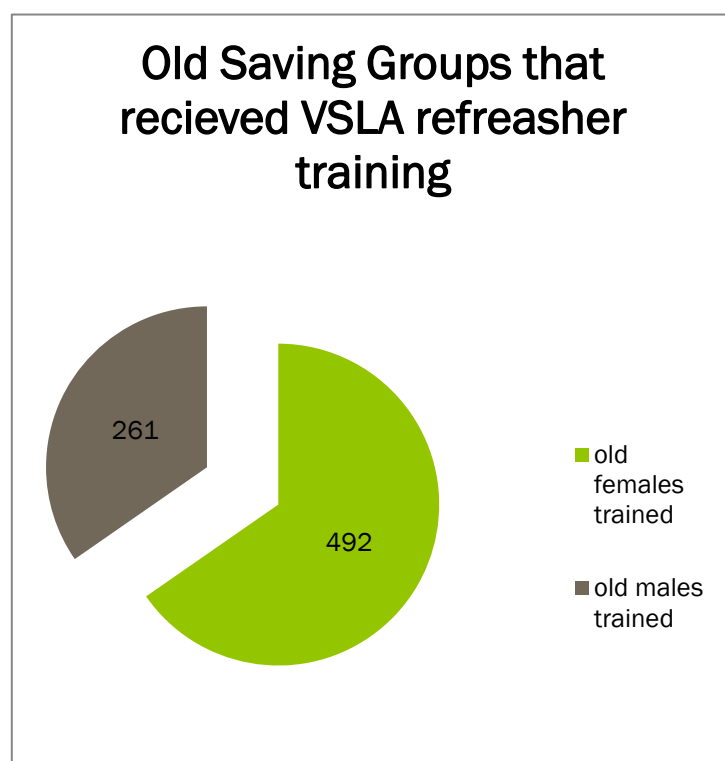
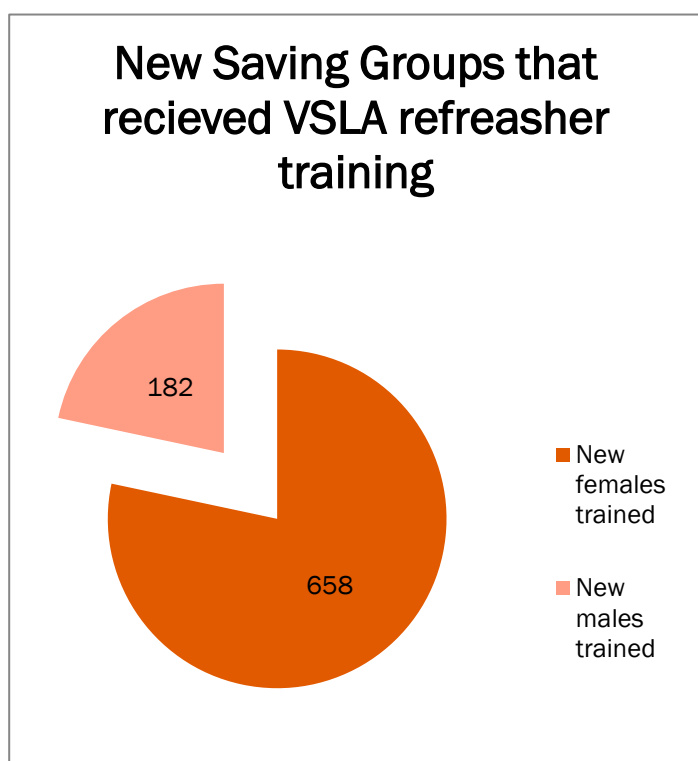

Outcome 3: Enhanced participation of community members and local leaders in child-protection, GBV mitigation and livelihoods improvement initiatives in Napak District

The held Sub-county stakeholder review meetings were for strengthened coordination and collaboration of the stakeholders, popularizing the by-laws and bringing on board the transport sectors that are involved in trafficking. And they involved sub-county leaders, opinion leaders, change agents, local council and religious leaders

Increased stakeholders participation has been realized through stakeholders analysis meetings conducted targeting the RDC, LCV vice person, CFPU, Councilors, probation office, CDO"s, LC3"s, religious leaders, group Members, Parents and the CaR consortium partners as shown in the photo below.

Outcome 4: Improved communication, lobby and advocacy strategy to eliminate child outmigration from Karamoja.

Information sharing and dissemination was done using MDD activities with children, community members participating in international days like Independence day celebration, the day of African child, and the 16th days of GBV activism that was coordinated by Napak District Local government officials.

Presentations through music, dance and drama to communicate messages of child protection, and their voices were heard especially on returning of guns that have caused insecurity in the region and parents embracing education for all children.

CaR team rescued and re-united 20 children (8 boys and 12 girls) with their caretakers in the course of Karamoja cultural events week hosted by Napak District.

Sensitization and dissemination of messages using jingle was produced, recorded and aired through Ateker FM radio station at Moroto district. Information disseminated was ***“Uganda Change Agent Association in partnership with C&D, Dwelling Places and Napak Local Government, are committed to stop child trafficking, discourage unsafe out migration of children to the streets, stop child labour, and calling upon parents to take their children to school. The caretakers are encouraged to join saving groups, so that they are able to get loans and start income generating activities to provide basic needs for their children.***

Let’s stop parading children on the streets under the hot sun, which will spoil the brains of these children as seen on the streets of Kampala. Parents lets learn to work together for the good environment for our children as they look up to their parents. AND ITS SUPPORTED BY KERK IN ACTIE, THE NETHERLANDS”.

UCAA also mobilized children who participated and disseminated child protection messages, and messages demanding for their rights to be respected and this resulted to district officers have taken the issues of children seriously since then; they promised to organize and strengthen the child wellbeing committees; as well the emphasis will be put on the caretakers to take the children to school.

It is noted that visibility was created for the need to continue supporting child rights members with the same communities and this was done through assorted IEC Visibility. Material Development and production that includes assorted 120 T –Shirts, and 285 Calendars.

Outcome 5: Results-oriented and impact-driven CaR Consortium coordination, Monitoring and Evaluation (M&E) systems.

Quarterly reviews of CaR activities were conducted, coordination for smooth implementation of CaR activities and more team building among CaR team emphasized.

Proper planning for the district dialogue meetings between Ministry of Gender, KCCA Officer, CaR partners and Napak district official were conducted that aimed to provide proper guide lines for information dissemination, project implementation and submitting the financial and narrative reports.

Strengthening the networking, coordination and proper strategies on how to rescue street connected children from the streets of Kampala was achieved through a national dialogue meeting involving 40 participants conducted in Napak and training that involved the Kampala Capital City Authority (KCCA) enforcement officers, ministry of gender, CaR partners and the Napak district officials where they created an ally among themselves in protecting children's rights so that out migration to the streets is reduced.

NETWORKING ACTIVITIES

CaR partners provided support to two girls & two boys formerly street connected children, rescued and resettled in Napak District, to participate in the CSO's symposium for children's dialogue, on children's right which was a celebration of 25 years for UCRNN for service. and they promised to sensitize other children when schools opens, they gained courage in discussing safeguarding concerns, they gained self-

esteem and it encouraged them to continue with their studies, and become role models in their communities, and others are able to learn and emulate from them.

A learning Visit by one of the UCAA Partners- Kinder not hilfe (KNH) Uganda Country office was conducted in Napak district for KNH to learn from what the CaR consortium was implementing in the area of ensuring that children on the streets are rescued, resettled, their Livelihoods supported and protected.

Facilitation in terms of transportation support was provided by UCAA to CFPU Napak, on cases of trafficking of children from Napak, through taking of perpetrators to Moroto district court and a total of 15 perpetrators to court (11 women and 4 men), and twelve were convicted (9 women and 3 men) was achieved and managed.

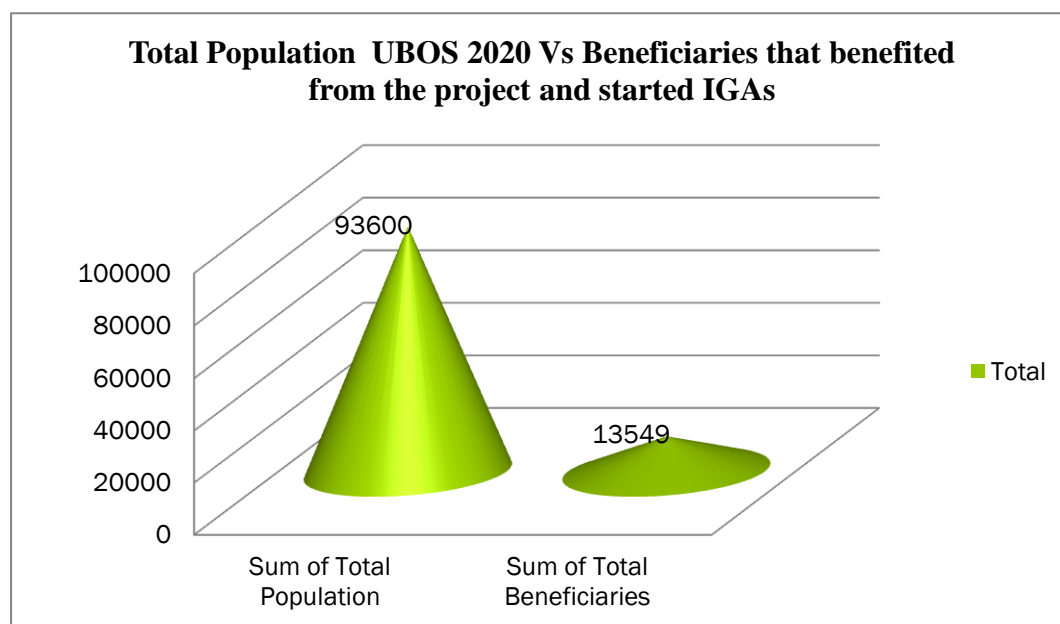
PROGRESS MONITORING

UCAA and partners were/are supervising a total of 109 saving groups cutting a cross Lorengecora, Iriiri, Ngoloriet, Lokopo, Lopeei, Matany sub counties, and Napak, Kangole, Matany town councils, in Napak district. VSLAs members saved up to a total of UGX 403, 572,000/= by the end of November, 2023. The saving culture helped members to take loans and many started some income generating activities. Below are the examples of established IGAs.

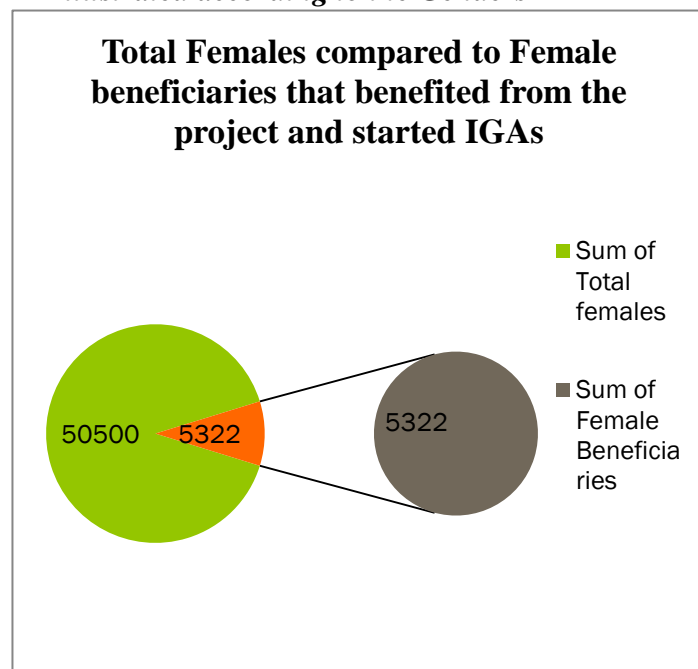

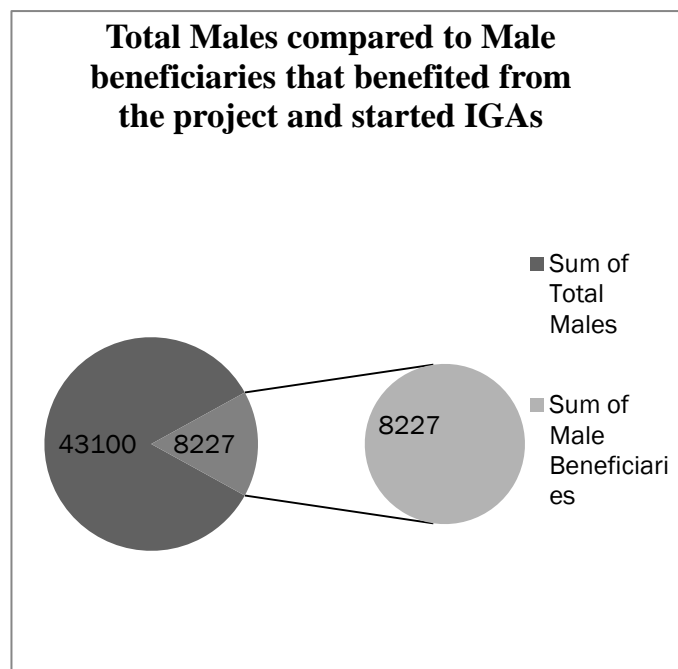

CaR Success stories

Title: 14-year old Pedro Emmanuel went missing from his home due to peer pressure from his friends.

Imagine a situation where a child is influenced to leave his home, village in Napak district with promises of a better life, only to realize that there was no Shelter and food for him and he had to tirelessly work his way through to get access to the basic needs he needed to survive.

Since Karamoja region is faced with high poverty rates, food challenges among others, many children are easily persuaded to leave their homes for a better life out there, which is always not the case, like what happened to this 14 year old boy, Pedro Emmanuel was influenced and left his home village in Napak to another village in Amuria district.

The consortium partners supported the office of the DCFPU for the rescue of Pedro Emmanuel, when his mother Nawal Paska reported the case to the office of DCFPU seeking support to rescue her son from Ogwete village in Amuria.

A community dialogue meeting was held with Napak district police, Amuria district police with support from UCAA in the Ogwete village. The LC1 Omatum Peter said that he has been seeing this boy in different homes doing herding of cattle but he did not know the person who brought him there. He said that he was grateful for the mother who had come for him. The LC 1 also emphasized to the community members to never keep anyone's child in their homes for their own interests having in mind that child labor is a criminal offence.

The team managed to successfully rescue the boy, and together with his mother they were counseled by the UCAA GBV officer Akongo Mary Lilly at Kangole police station, and taken back to their village.

Project 2: Climate Innovations for Resilience in Karamoja and Kyangwali (CLIRK) Project

Project Overview

UCAA in partnership with CARE International in Uganda are implementing the *Climate Innovations for Resilience in* Kikuube district (Kyangwali) and Karamoja districts of Kotido (Maaru Sub County), and Karenga (Kapedo Sub County). The CLIRK project impact goal is: Improved food and nutritional security for land scarce poor and climate vulnerable communities in Kyangwali and Karamoja regions.

Since these regions are affected with disasters caused by climate change, for karamoja there is prolonged drought which impacts on crops, livestock & water resources, and kyangwali has a challenge with Small plots/land holdings, for food production in and out of Kyangwali refugee settlement. UCAA in partnership with CARE are implementing activities, practices and research to absorb the shock and risks that come with Climate change: To improve use of valley dams for pastoralists and agro-pastoralists, for drought resilience in karamoja and Sustainable food production on small plots/land holdings in Kyangwali Refugee settlement and host communities in Kikuube district.

The activities are/were implemented in a participatory approach with various stakeholders and target populations enlisted in the table below.

The activities that were implemented contributed to two project goals, one in Karamoja and the other in Kyangwali regions, and they focus on ensuring that communities who were in a state of extreme food insecurity could produce and trade in food. The project ensured that: It integrated principles of human rights and the rights of indigenous peoples, Gender-disaggregated indicators and recognized the important role played by women and men in the agriculture and food sector, Capacity development approach was integrated at the systemic, institutional and individual levels, according to needs expressed during the implementation of the activities.

Note: The activities implemented strengthened the capacities of districts of Karenga, Kotido and Kikuube districts in climate change adaptation and disaster risk reduction and SGBV aspects, the main activities implemented include the following;

Outcome 1: Increased capacity of local organization and structures to address disasters and impacts of climate change at community level.

Activities implemented and results for Output1

Conducted entry meetings at the District level to identify actions that have been taken in regards to the DCP and come up with action plan for Kikuube, Kotido and Karenga districts

During the district level meetings, they identified actions in regards to the DCP and come up with action plans for Kikuube, Kotido and Karenga districts:

99 District officials attended (36 females, 63 males) the entry meetings and they discussed:

- The status on DCPs, revised district hazards and risk profiles and action points were documented

Conducted meetings to review the district hazards and risk profiles and came up with plans

9 individuals (5 females, 4 males) met, members of the district risk management committee and UCAA staff

- The meetings aimed at reviewing the profile of hazards for the 3 districts to come up with the new profile of the hazards affecting the districts, and the following were identified

Kikuube: Migratory population, Human disease, Food insecurity, Environmental degradation and road accidents.

Kotido: there was prolonged drought resulting in to food shortage, and

Karenga: on top of prolonged drought, there was a conflict between Wild life and Human because of climate change and in the process wild animals destroy crops for the human population.

Note: The hazard profiles were outdated and needed review with experienced district staff this helped UCAA and CARE get updated information that could be used in the project's advocacy work.

Conducted Meetings with UCAA structures to embrace and support the project implementation for sustainability

19 people attended these meetings (10 females, 9 males)

- The project concepts, work plans, objectives and implementation plans focusing on feasibility, approach partnership and sustainability were discussed with the change agents

Technical capacity building of staff of District Local Government on climate change, disaster risk mitigation and adaptation and humanitarian action

49 staff members were trained on DRMC (15 females, 34 males)

- Topics covered were: Understanding Disaster risk and Disaster risk frame works, Hazards, Capacity and Vulnerability.
- Looked at the causes of disaster risks, Prevention, Preparedness and Response, and conducting vulnerable capacity assessment.

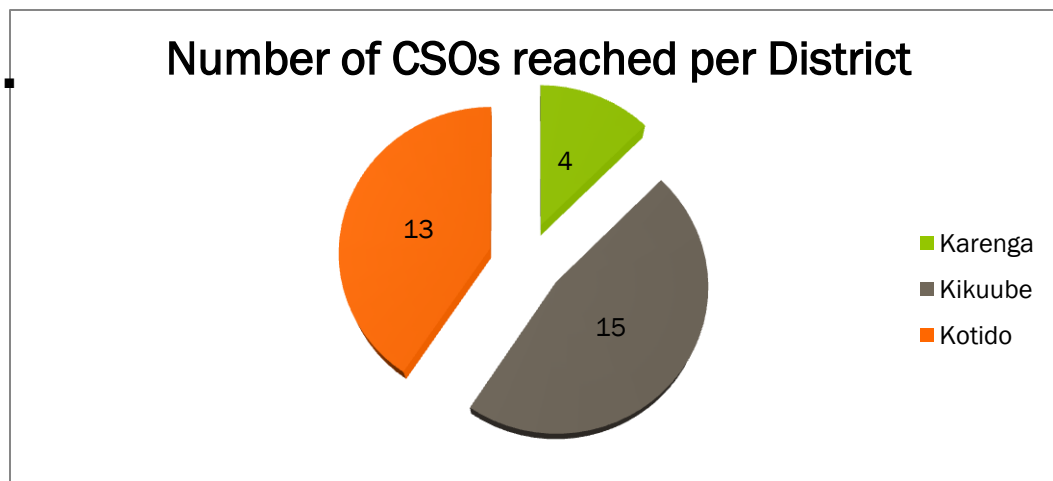
Through experience sharing and learning among participants, they were also equipped with knowledge and skills on how to manage disasters/hazards in their districts.

Designed IEC Materials with advocacy messages addressing the project objectives

220 wall calendars, 2 signpost and 9 workshop pull banners were designed

- Wall calendars and table calendars for 2024 were produced by UCAA and were all distributed to stakeholders portraying the message. So far, 2 sign posts for Kotido have been produced and installed. In addition 3 workshop pull up banners were produced for all the 3 districts.

Conduct training and assets needs assessment for the identified CSOs, CBOs, activists, start-ups, media coalitions and networks



4 CSOs were reached in Karenga, 13 in Kotido and 15 in Kikuube Districts

The CSOs, startups, media coalitions were trained and equipped their capacity in DRR aspects such as how to mainstream GBV and DRR mitigations in the humanitarian interventions and technology that can aid understanding climate change.

There was however need for: Networking, organize and train more on risk assessment, management and mitigation and many more evidenced by the activity report and challenges documented.

Review of training materials

▪ To realize UCAA's objective of building the capacity of its staff and partners in DRR and CRM, a consultant was contracted to review the existing UCAA's training manual, so as to establish consistency in the training of stakeholders in climate risk management.

Assets needs assessment was conducted with the following

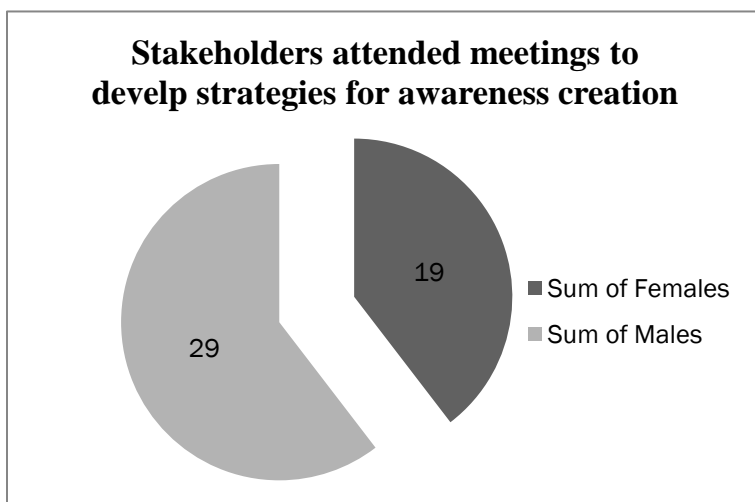
- To analyze how climate risk and humanitarian situation in Karamoja and Kikuube had shaped CRM training content and pedagogy.
- To identify capacity gaps in climate risk management and humanitarian response
- To identify and priorities key capacities for CRM and humanitarian response
- To assess the humanitarian physical assets and capacity needs required to meet priorities for an effective CRM and humanitarian response.
- To recommend a curriculum/training package that would effectively address knowledge and skill gaps in CRM and DRM

Outcome 3: Increased capacity of local organization and structures to address disasters and impacts of climate change at community level in Kikuube, Karenga and Kotido districts.

Activities implemented and results

Conducted meetings with key stakeholders of Kikuube, Kotido and Karenga districts to develop a strategy and themes for awareness creation on GBV and DRR

The meetings in all the 3 districts we attended by a total of 48 Stakeholders, 29 Males and 19 Females.



Meetings were to develop a strategy and themes for awareness on DRR and GBV and UCAA documented them.

- Key stakeholders involved: participants from department of Natural Resource, Production environment, Gender official among others.

Conducted an assessment to identify media to disseminate information on DRR and GBV form Kikuube, Kotido and Karenga districts

11 radio stations. (2 Karenga, 6 Kikuube, and 3 Kotido) were assessed and a list of appropriate ones was identified.

- Assessment and selection was determinant on the station organogram, listenership coverage, prices, audio quality and location for security purposes among others. And these were selected Etoil A Karamoja FM for Karamoja and Spice FM for Kikuube.

The talk show started with remarks from UCAA staff who gave an overview on UCAA, objective of the radio talk show, details of the CLIRK project in terms of geography, time scope, and goal and target

population. The talk shows were conducted in the local language with translators were available where necessary to reach a large population.

Results of the catchment area were evidenced from listeners' calls made during the talk shows, where listeners had some knowledge on SGBV, DRR and the place from which they were listening in from.

Select and facilitate stakeholders to undertake awareness creation on DRR and GBV in Kikuube, Kotido and Karenga districts

A total of 6 stakeholders were selected and facilitated to create awareness

- Awareness creation was through community sensitization radio talk shows, art (MDD), and brochures in Kikuube, Kotido and Karenga districts

Community meetings were also conducted in Kikuube district for awareness creation.

It was noted that throughout the implementation of these activities the project built on existing venues and platforms and created avenues for a stronger dialogue: this restores trust, promotes integration of DRR and SGBV aspects and allows for the emergence of better ownership by local communities themselves hence sustainability.

Through the implementation of these activities there was strengthened collaboration of government structures and other stakeholders for fully support of the project.

In conclusion

The success and sustainability of the project heavily relies on strategic partnerships with all the stakeholders and empowering communities, this promotes synergies and adds value to the implementation process of the project.

Project 3: Project for Enhancement of Youth Employment and Agency in West Nile Region, Uganda

Project Overview

The project was implemented from: start date 1st of March 2020 to 28th of Feb 2023, where the reporting year had an implementation of basically 2 months of January to February 2023. During this period the project was finalizing, preparing accountability and activity reports that were made during the implementation periods.

The project objective was: Youth Economic Empowerment in Uganda, a key factor for political stability, good governance and economic development by targeting both urban and rural youth in community settings integrating both refugees and refugee host communities.

The project for enhancement of youth employment was implemented in Yumbe, Moyo, Obongi and Adjumani districts: where 60% of the population constitutes of young people. For various reasons (including technological advancement, limited resources, low levels of education among others, the category of the youth aged 18-35 are the most affected by unemployment).



The project was implemented, in conformity with the UCAA country strategy to supplement on the government's interventions such as the Youth Livelihood Fund (YLF).

In addition the project interventions implemented addresses key areas of advocacy and accountability issues of the National Development Plan (NDPIII) of regional and global development, private sector development, sustainable urbanisation and housing, community mobilization and mind-set change which are tasking elements in the project implementation areas, they also address the UN Sustainable Development Goals (SDG) of namely 1 (End poverty in all its forms everywhere), 4 (Ensure inclusive, equitable education and promote lifelong learning opportunities for all), 5 (Achieve Gender equality and

empower all women and girls), 8 (Decent Work and Economic growth) and 10 (Reduced inequalities within and among communities).

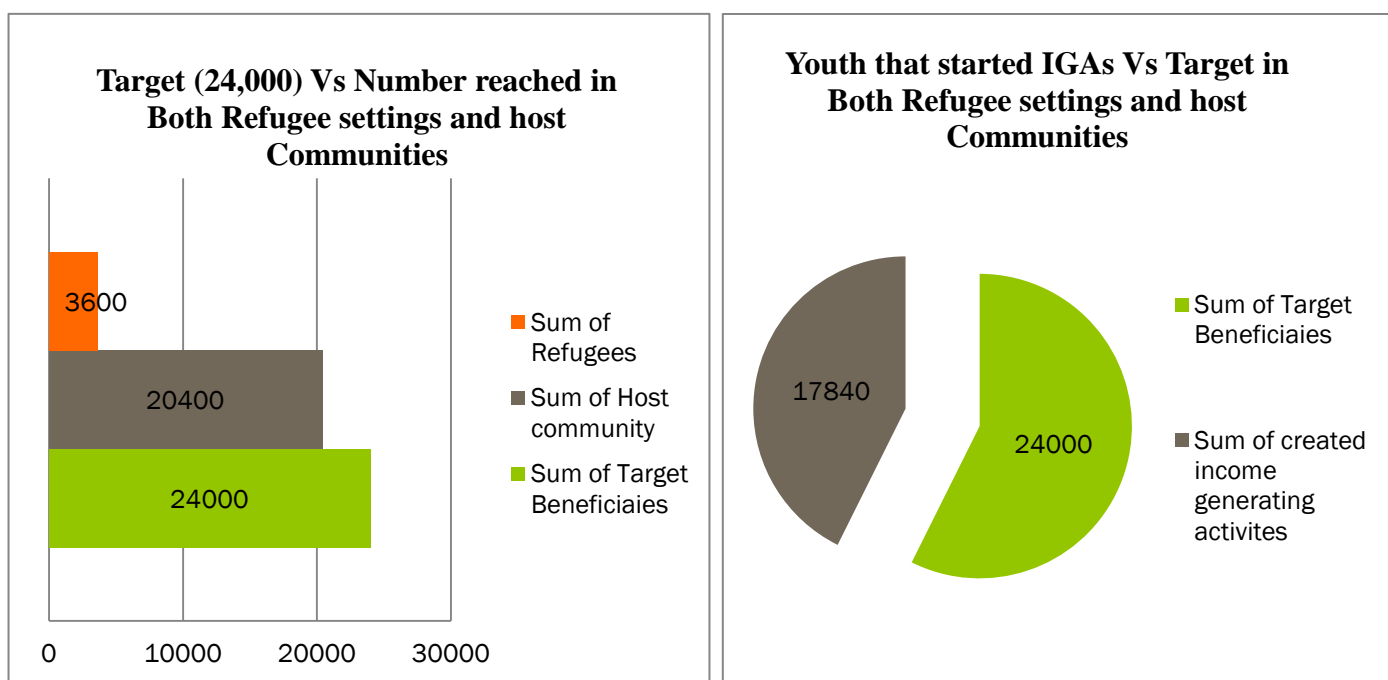
These are evidenced by the higher number of youth creating income generating activities and were all linked to other plans intended to guide the provision of sustainable quality services, to minimize the vulnerability of youths and propel them into responsible citizens.

Target Counties/ Regions: Uganda, West Nile Region(Yumbe. Moyo-Obongi and Adjumani districts)

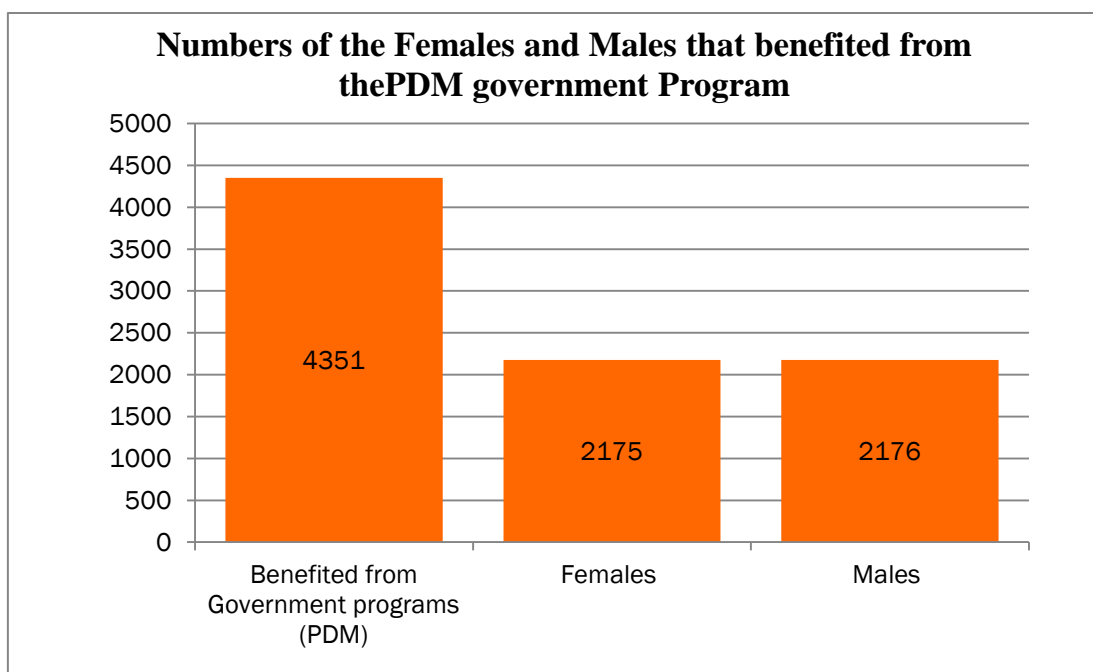
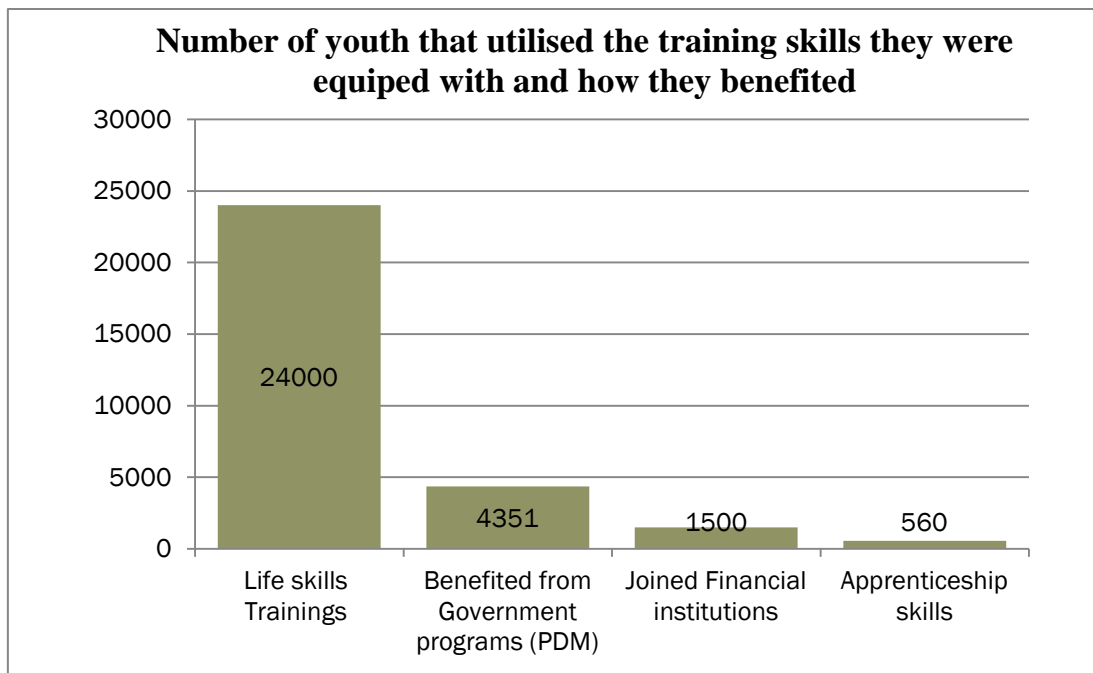
Below is a brief summary of the project during it's life span, key activites and results.

Final beneficiaries were the target youth, their households and communities in the immediate neighborhoods of the participating households. The action targeted the most vulnerable youths from the households in the refugee settlements and the host communities in districts of Adjumani, Moyo and Yumbe.

The targets and selection were allocated based on the proportion of each districts' youth population. The project ensured that 50% of the target was females and 50% males. This achievement was 74% of the project target.



The 24,000 youth were equipped with Life skills, advocacy and some benefited from the parish development model of the government of Uganda, apprenticeship skills as illustrated in the graphs below.



The total linkage rate of youth was 5,851 (24%) linkages and the reason for this, was that majority of the youth needed some more time to get organized in terms of requirements such as what government requires, and those of other institutions which was a challenge since the project had time limits of implementation.

Below are some youth showcasing their created income generating activities.

Project 4: Improving Livelihoods of Women and Children of Agago District through Self Help Group Approach (SHGA) Program

SHGA Program overview

UCAA has been implementing the Self Help Group Approach program in Adilang Sub-county of Agago district for seven years now.

The project object: Is improving the livelihoods of women and Children in Agago district located within Acholi sub region northern Uganda. UCAA used the approach of bringing the poor, often voiceless, powerless and vulnerable people together, and empowering them gain tremendous strength and

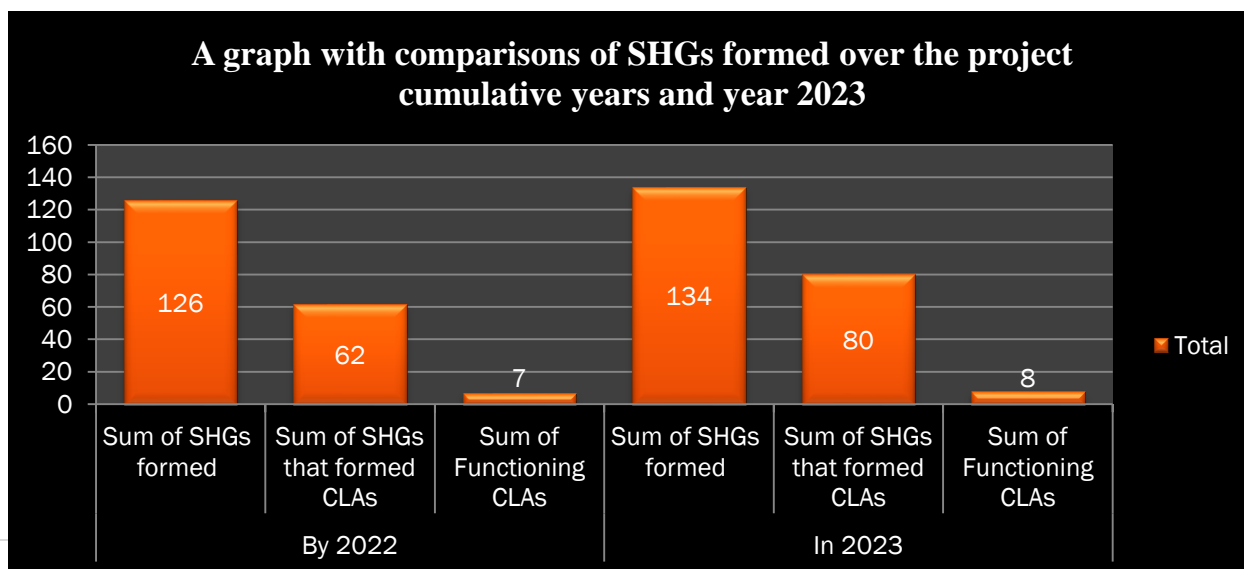
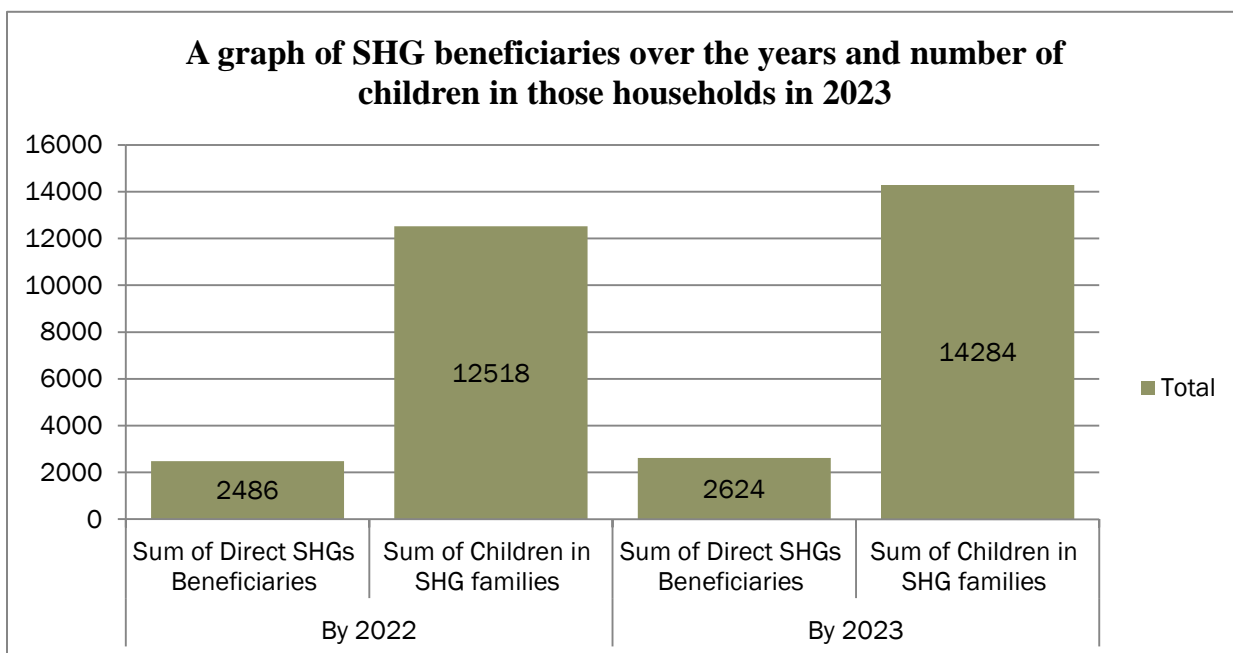
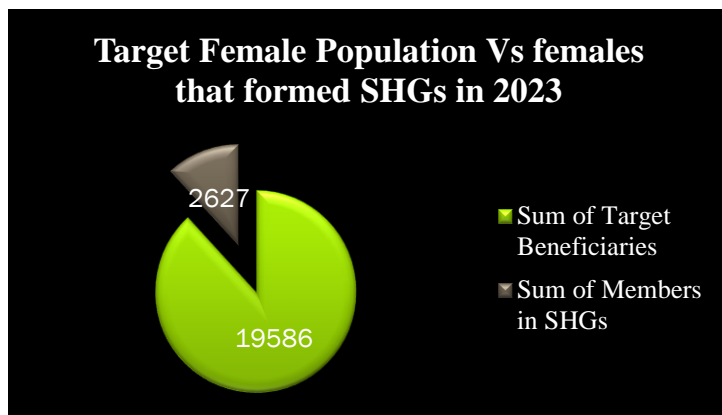


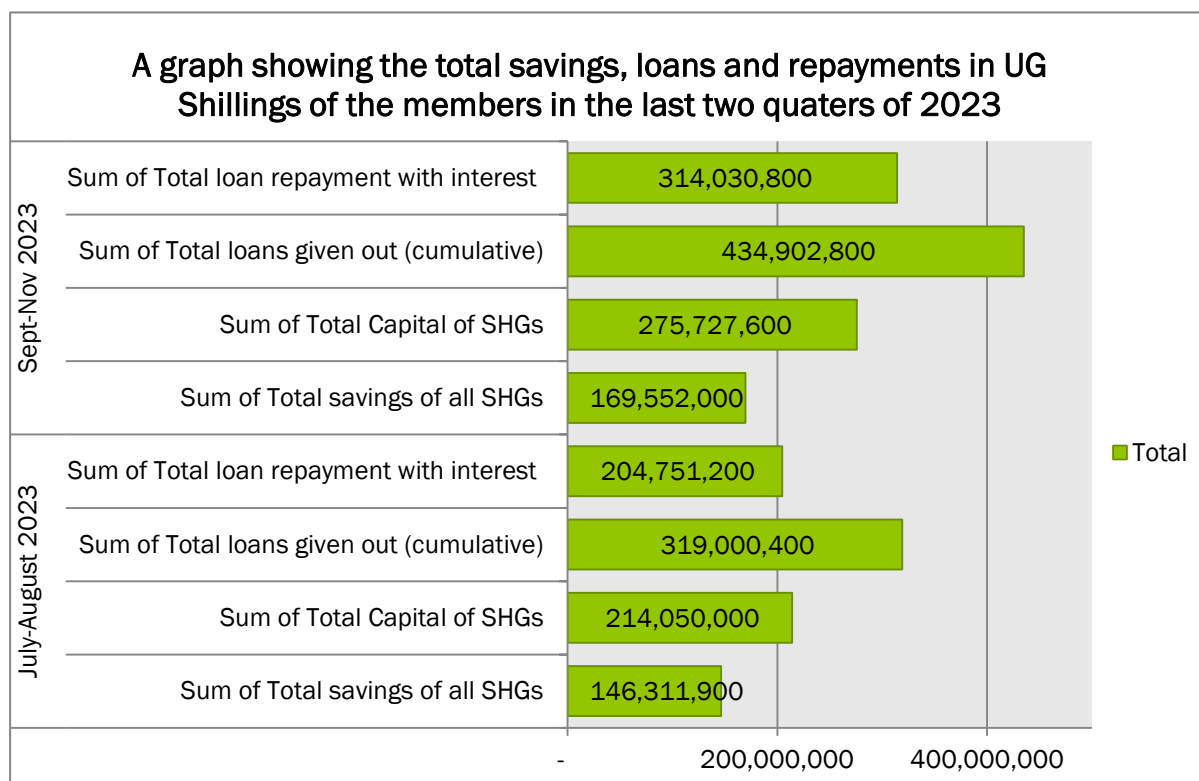
collective thinking hence adding a lot of value to each individual despite the group effort.

UCAA focused on activities of capacity building for the self-help groups through trainings, encouraging the groups to build good relationships and networks, coming together and forming networks (Cluster level Associations). These SHGs were formed through transect walks and mapping, to be able gather people of the same socio-economic status. The approach created a culture of savings and loaning amongst members of the SHG, Women were empowered through trainings, weekly meetings and rotational leadership, working with homogenous group is easier because they understand one another's problems/challenges better.

Below are some results for 2023 Activity implementations of UCAA in Adilang Sub-county Agago district

13.41% of the Females in Adilang Sub County Agago District joined and formed SHGs in the community





196 women were saving regularly and accessing loans from their SHGs, Formation of New SHGs target was 25, however 10 were achieved, the target was affected by other community engagements like PDM.

Women save and start business while accessing small loans from their savings groups and the loans to savings ratio was 2:1 in July August quarter and 2:2 in September to Dec quarter.

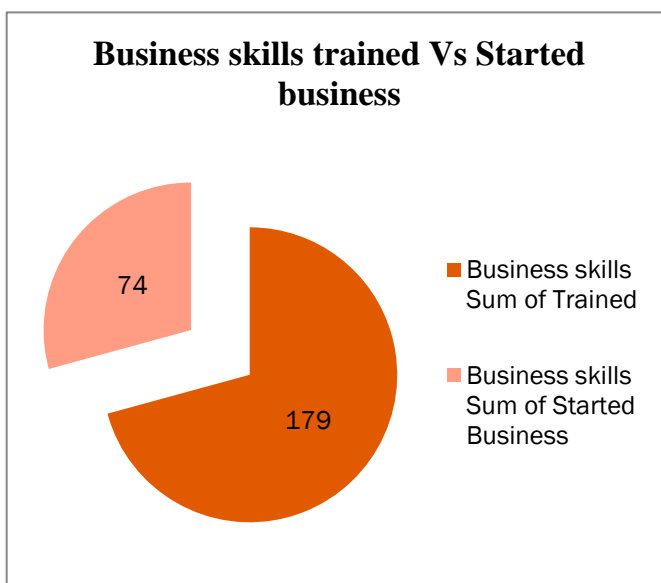
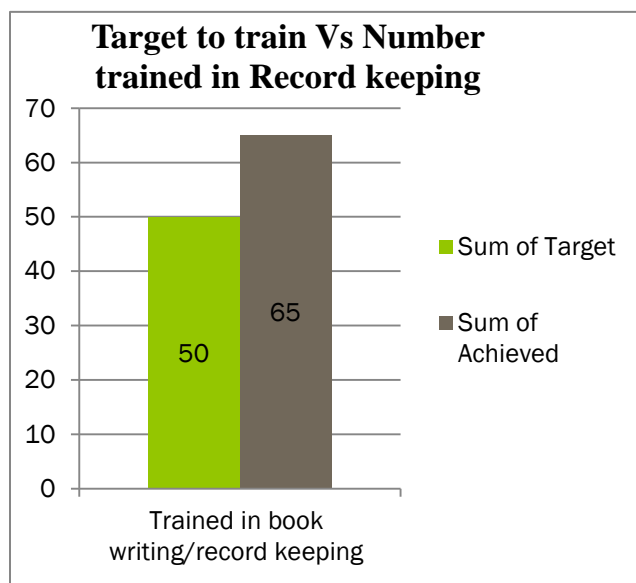
The table below shows how the groups were active within a period of 2 quarters July-August and Sept- Nov 2023.

In the self- help groups formulated (new and old) UCAA implemented other activities to support the groups’ foundation and guidance over time.

- **Training of new book writers**

Target was 50, the project delivered 65 book writers by the end of the year, they were trained in proper record keeping which helps in managing the saving groups’ money accounts

- 179 women from 10 old SHGs were trained in one day, on basic business skills and 74 women have started viable businesses thus making profit.



The pictures below show UCAA conducting some of the trainings in book keeping and business skilling in some of the SHGs in Adilang Sub-county Agago district.



- 11 review meetings with 8 CFs were conducted by the PO between January and December.

- 371 women from 20 SHGs were taken through the training on SHG concept of savings, group capital management and records, the members embraced the approach this increased the SHG capital.
- A total of 320 women from 20 new SHGs were reached out and trained on goal setting and self-assessment.

- Supported 4 CFs during hands on training on business coaching and a total of 8 women underwent business coaching.

- Offered training on conflict resolution and problem solving to 15 old SHGs. This improved the well-being of 294 members under the SHG household.



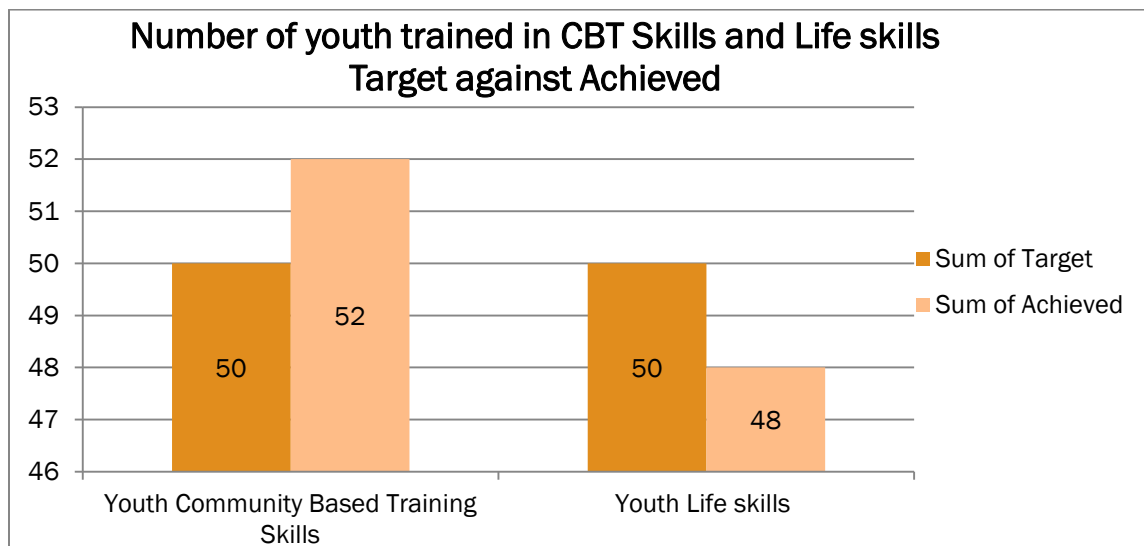

- Provided training on CLA concept to 35 SHGs and about 633 members are aware of the CLA and the need to have it in their communities.
- A total of 35 SHGs were assessed using the PG and FA tools. 26 SHG are already part of the CLA representing 518 women in their respective communities.
- 26 SHGs were reached and prepared to form CLAs in their communities.
- 8 SHGs and 3 CLAs were facilitated to conduct exposure visit amongst them. This enhanced SHG and CLA activities.
- 3 new CLAs were to be formed however 1 CLA comprising of 8 SHGs was formed in December as other SHGs were not yet prepared by that period.
- 18 SHGs, 6 CLAs and 2 CBT were monitored during the period, to assess progress, challenges, and lessons to be worked on.

Conducting training for 4 CBT committee less than 4 CLAs were planned but 3 CBT committees were trained on their roles under CLAs hence a total of 33 committee members equipped with CBT knowledge and they are implementing it in their communities. One CLA dropped off in implementing CBT due to capacity gap.

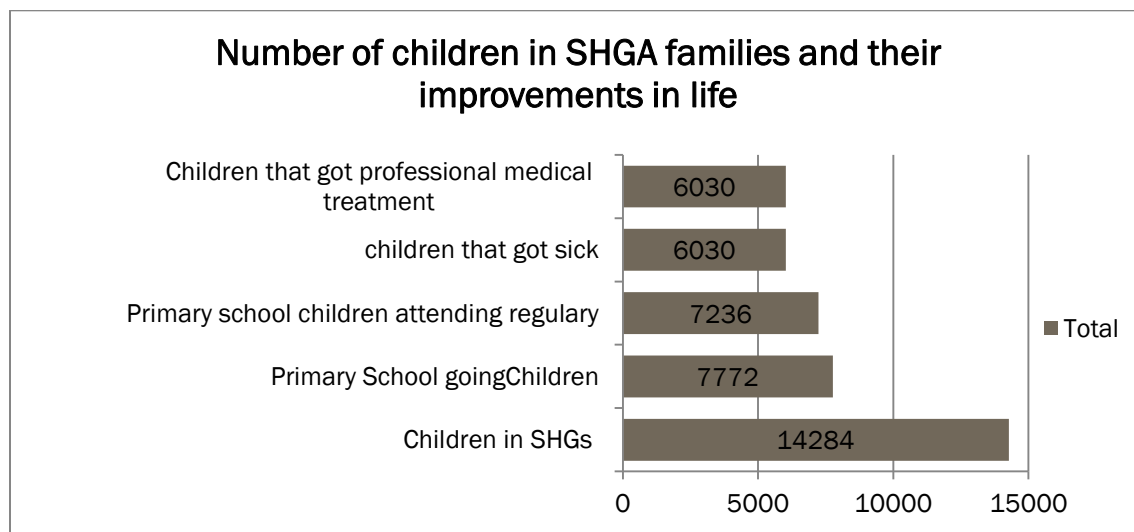


The 2 photos below show some of the attained Community based training skills among the youth, community practice in Adilang Sub-county Agago district 2023: Mechanics and tailoring



- Formation of youth groups under 4 CLAs, but 3 youth groups were established and the youth are performing their activities such as meetings, savings, loan taking and farming. One CLA dropped off in implementing CBT due to low capacity.

Involvement of children from the SHGs beneficiaries, and formation of Children's groups in the age groups of 7-11 and 12-16.

Some encountered challenges in the implementation that affected targets were, where community members were engaged in other activities, inflation affecting prices of essentials and the need for innovative interventions to address child protection and GBV issues. For the next project phases, activities were rescheduled, SHGs were trained on priority ranking, some of the innovative interventions included CLAs subcommittees, community-led initiatives for clean water access, plans for phasing out involved continued formation and strengthening of SHGs and CLAs, fostering relationships with stakeholders for sustainability, and empowering the community.

Case studies from some of the implemented SHGA projects

Case story 1: A 20 year old elder son gets a chance to improve his and family living standards

Lukwiya Deogracious is a 20 year old male youth living with a single parent mother and 6 other dependent siblings in Ligi ligi community Agago district.

Agago district is one of the remote districts in Northern Uganda with vulnerable poor, often voiceless and powerless people-youth and women.

Uganda Change Agent Association has been implementing SHG approach in Agago since 2018 up to date and introduced Community Based Training (CBT) to Ribbe Kacel Kelo Kuc CLA in 2022. 21 youth were enrolled into the CBT program where Lukwiya Deogracious was among in October 2022. He is an active member of the youth group and also entrusted with the secretary role.

Deogracious Lukwiya enrolled for one of the life training skills of motorcycle repair with two other youths; underwent training for six months with close monitoring of CBT committee and his mother who is a member of Walegu Gum SHG.

After a successful completion of the CBT program in September 2023, Deogracious Lukwiya was retained by his local trainer (Olum Denish) for his knowledge and skills of motorcycle repair and customer care. He is gaining more technical and advanced skills in motorcycle repair. And he has created networks with customers and people around the community. He earns an average of 7000-10000 daily and able to save an estimate of UGX 80,000 per month. Deogracious Lukwiya is supporting his mother to meet the basic needs of the family including education of his siblings who are in primary education. His future plan is to start his own motorcycle repair garage in their community by the end of 2024.

Case story 2: An orphaned school dropout young Mother, linked to greater opportunities

Prossy Achan is a 23-year-old mother of one child, Senior 2 School dropped out in 2017 after losing both parents, currently staying with her grandmother Marcela Atwol, who is a member of Ogen Rwot SHG that was established by Uganda Change Agent Association in 2018. The SHG is attached to Ribbe kacel kelo kuc CLA in Kanyipa community.

In April 2023, the CLA created a linkage with TASO-Uganda which is supporting Adolescent girls and young mothers under the TASO-Uganda DREAMS project in Agago district. Prossy Achan was among the adolescent girls and young mothers in Adilang community who was enrolled into TASO project as a result of linkages by the CLA.

In May 2023, Prossy Achan was enrolled for a youth skilling program for a six months tailoring course at Passion 4 Community (P4C) with financial support from TASO. She learnt various fashions and designs as far as tailoring and garment cutting, also received a number of training on life skills, business skills, and financial literacy in addition to the tailoring skills.

After successful completion of the course, she was provided with start-up kits which included one new sewing machine and all the materials. Prossy Achan is prepared and determined to begin practicing the skill and making both children and adult clothes for sale during festive seasons

Her future plan is to advance in tailoring career by 2024, provide quality education for her child and take good care of her grandmother and family as well.

In conclusion
